FUNCTIONS AND RESPONSIBILITIES OF THE COMMITTEE

9. To sensitize SMS (Social Distance-Mask-Sanitize) Rule in the campus.
10. To bring awareness on COVID safety measures to students followed in campus, at canteen, labs and Library.
