This is regarding Compliance Reports submitted by **Narasaraopeta Engineering College, Kotappaonda Road, Yellamanda Post, Andhra Pradesh-522601** for the UG Engineering programs which were accredited by NBA in Tier-II for academic years 2017-18 to 2019-20 whose validity has expired on 30.06.2020.

2. The National Board of Accreditation (NBA) has decided that in all cases of UG Engineering programs which were accredited in Tier I/Tier II for a period of 3 years upto 30-06-2020 and for which the concerned Institutions have submitted Compliance Reports but their visits for data verification of the programs are pending because of the current pandemic situation due to Corona virus, the programs will be considered for further accreditation of one year i.e. upto 30-06-2021 after data verification of the programs in NBA on the basis of the submitted Compliance Reports. 3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

The accreditation status awarded to the programs as indicated in the above table does not imply that the accreditation has been granted to **Narasaraopeta Engineering College, Kotappaonda Road, Yellamanda Post, Andhra Pradesh-522601** as a whole. **As such the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation.
