In the letter under reference, the UGC, New Delhi has communicated the conferment of Autonomous status to "Narasaraopeta Engineering College, Kotappakonda Road, Yellamanda(Post), Narasaraopet, Guntur District, Andhra Pradesh" for a period of six years i.e., from the Academic year 2016-2017 to 2021-2022.

In this connection, I am by direction, wish to endorse the orders of the UGC regarding conferment of fresh Autonomous status to "Narasaraopeta Engineering College, Kotappakonda Road, Yellamanda(Post), Narasaraopet, Guntur District, Andhra Pradesh" from the Academic years 2016-2017 to 2021-2022, subject to fulfillment of the following conditions:-

- a. "Narasaraopeta Engineering College, Kotappakonda Road, Yellamanda(Post). Narasaraopet, Guntur District, Andhra Pradesh", shall continue its affiliation to JNTUK in future also at least till the recommended period of autonomy expires. The autonomy shall cease to exist on discontinuation of affiliation.
- b. The students presently enrolled in the "Narasaraopeta Engineering College, Kotappakonda Road, Yellamanda(Post), Narasaraopet, Guntur District, Andhra Pradesh", shall continue to be governed by the academic regulations of JNTUK Kakinada.
- c. The admission procedures to be followed by the "Narasaraopeta Engineering College, Kotappakonda Road, Yellamanda(Post), Narasaraopet, Guntur District, Andhra Pradesh", shall continue to remain the same as those of APSCHE/JNTUK for various programs run by it even after acquiring autonomous status.

- d. The autonomous status for the "Narasaraopeta Engineering College, Kotappakonda Road, Yellamanda(Post), Narasaraopet, Guntur District, Andhra Pradesh" shall come into force with effect from the academic year 2016-17...
- e. The college shall follow the guidelines issued by the UGC in all matters.
- f. The college shall constitute the necessary Statutory Bodies and inform the University.
- g. There shall be no financial commitment on the part of JNTUK Kakinada and the college shall continue to pay all administrative/affiliation fees due to the University as usual.
